

## **A Federal Court Approved This Legal Notice**

**By entering into a consumer contract with an Aaron's, Inc.-owned store in New Jersey between March 16, 2006 and March 31, 2011, you are part of a class action in a federal court. You will stay in the class action unless you remove yourself.**

Some customers of Aaron's, Inc. in New Jersey signed contracts that included certain fees alleged to violate several New Jersey consumer laws. A class action lawsuit is trying to get money for these customers. It also seeks to stop Aaron's from charging these fees in New Jersey.

If you are a Class member, your legal rights are affected by this lawsuit, and you have a choice to make now.

This lawsuit is called *Korow v. Aaron's, Inc.*, Case No. 10-6317. It is being heard by the United States District Court for the District of New Jersey, which authorized this notice.

### **You Are a Class Member**

Aaron's records show that you entered into a rent-to-own contract at one of its New Jersey stores sometime from March 16, 2006 to March 31, 2011. This makes you a member of the Court-approved Class.

A class is a group of people who share a common legal claim against the same party, in this case against Aaron's, Inc.

### **This Lawsuit Is About Certain Fees Charged by Aaron's Inc.**

This lawsuit claims that Aaron's, Inc. violated several New Jersey consumer protection laws by charging certain fees in its rent-to-own contracts. These fees are referred to in Aaron's, Inc.'s contracts as:

- a monthly "Service Plus" fee, and
- a "Return Check" fee charged if a customer's check is returned "for any reason."

The lawsuit seeks to obtain money for you and other Class members for these claims. For example, for the class representative, Ms. Korow, the lawsuit seeks about \$200 plus interest for one of the contracts she entered.

Aaron's denies that it violated any laws or that it must pay any Class member money. Aaron's filed a counterclaim alleging that Ms. Korow owes it money on one of her contracts.

### **You Can Stay in the Class by Doing Nothing or Can Remove Yourself**

**If you do nothing:** You will stay in this lawsuit, be represented by Class Counsel, keep the possibility of getting money or other benefits from a court judgment or settlement, and give up the right to file your own claims against Aaron's, Inc. on the same legal claims in this lawsuit.

**If you ask to be removed:** You will not be part of this lawsuit, will not be represented by Class Counsel, will not get any money or other benefits from this lawsuit, and will keep any right you have to file your own claims against Aaron's, Inc. about the same legal claims in this lawsuit.

### **To Remove Yourself, You Must Send a Signed Request by February 10, 2017**

To remove yourself, you must by **February 10, 2017** send a signed writing with your printed name, address, signature, and statement that you want to be removed from *Korrow v. Aaron's, Inc.*, Case Number 10-6317. The writing must be e-mailed, faxed, or mailed to:
